- Northern Collaborative Baccalaureate Nursing Program Policy Changes –Amanda Kirkham

The Nursing program has three separate changes to policies: academic performance policy, LPN admission requirements, and letter of permission policy.

Academic Performance Policy

Currently, if a student fails twice, they are required to withdraw and never able to reapply for NCBNP. Following research and discussion, we would like loosen the policy. It was suggested that if a student fails twice they must withdraw but can reapply after a minimum of 1 year. A committee of members from NWCC, UNBC and CNC would assess the reapplication of the student determining acceptance or not. Generally, NWCC has had an excellent success rate in the nursing program.

The CNC motion that was included in the documents is for background information on this decision.

LPN Admission Requirements

The LPN program has move from a certificate to a diploma. The first graduates are this summer from NWCC. The Collaborative decided to give the LPN program 3 additional credits. It will now have 27 transfer credits for LPN students, as in the past it was 24 transfer credits. It still takes students 4 years to progress through the RN program.

Letter of Permission Policy

Currently students need to take our courses as outlines. In some instances students want to take electives from other institutions. The letter now has an additional caveat that if students have committed an academic offense, we can refuse the letter of permission to take a course from another institution.

The reasoning behind this change is that the collaborative felt that the letter of permission was a privilege and people who have violated academic honesty will not be eligible for this privilege.

EDCO had the following questions regarding this policy change:

Why would we continue to penalize students if they had been caught and made reparations during that course in which they had an academic offence? What is their rationale?

There is an information sharing agreement with UNBC and NWCC so UNBC does have access to all information about academic offence. Our instructors do not phone UNBC regarding academic offences unless a patient's safety was in danger. Any conversations regarding collaborative processes need to take place at a different table.

ACTION ITEM: Amanda will take back the following suggested wording reframe: "All students may not be granted the letter of permission." EDCO feels that this wording doesn't sound pernicious if we don't link it to previous academic violations.

Amanda will take back the preceding suggestions and questions to be discussed with collaborative members. The change in the Letter of Permission policy will be tabled until it can be revisited at this table.

➤ Growing Through Giving—Debbie Stava

In regards to timetables Growing Through Giving has identified October 1st as the day of closure. Please inform all clusters and keep this in mind when scheduling classes. CAT members have also been informed to disseminate this information.

Growing Through Giving is an open day where other non-profits are encouraged to apply. The deadline for non-profits to submit their requests is March 14th. A link will be put on the website regarding this.

The nursing program is concerned because they are already linked with many community projects and Growing Through Giving does not speak to the programs that are already many community initiatives. It is a concern that it is a non-instructional day because other days have been identified that work better for the program and students. Several days have already been dedicated to giving back to the community but there is concern that we do not have autonomy.

We do want to encourage animate discussions about volunteering and giving back. Rocque suggestions to be clear about what the goal is and be very conscious about how to communicate amongst ourselves to try to reduce any conflict. Update the college community about these concerns. Once we have projects it will be easier to engage the staff

and students to create momentum about this project.

Discussion regarding the concerns of Growing Through Giving. Is it distracting to our stretched resources? What are other impacts that haven't been discussed at the Growing Through Giving committee? Clusters seem to have similar concerns.

How the goals of the event are established? Who are the participants? What are the goals for the community development project? Is this an event that is trying to build specific relationships with organizations in the community? Is there an assessment among ourselves for what we do in the community? What is the list? What are we currently doing? IS that a good list to have for a starting point of organizations to contact?

Should we move the volunteer day to a Saturday for a true volunteer day? This would avoid the cancellation of an instructional day, or do we all need to volunteer on the same day? Are there other ways to volunteer that fit better with the organic schedule to the non-profit organizations?

ACTION ITEM: Reto requested that Deb bring these concerns from EDCO forward to the Growing Through Giving committee.

ACTION ITEM: Growing Through Giving will be added to the March 28th agenda and will be a standing agenda item until October 2014.

Academic Cluster: The workloads were formally signed off on February 19th. 18 courses offered by videoconference. By April 1st we will have determined who is teaching which course at which campus by which mode of delivery.

ACTION ITEM: Video capacity and support needs to be an agenda item: technology plan. Invite Ivor to the next meeting for an update.

CCP Clusters: Schedules were submitted on February 21st. Switching to a learning center model, after a successful pilot from Houston. There are some concerns about the reduced full time staffing in CCP and our curriculum development is starting to suffer. Provincially articulated curriculum in the English classes which will be very useful material. It would be nice if there was enough money so that all articulation committees could attend the provincial meetings. We have 11 subcommittees and we only have money for 10 to go down.

BADM Cluster: They have been working with ABT to align some of their courses and to give transfer credit. BADM will now accept 2 UC credits to the diploma and are hoping the reverse to be true as well. Schedules are in and awaiting arrival to registrar's office.

ACE update: Larry white trying to identify different ways to modularize the program. Significant components that may be of interest to community members at large. Increase awareness of and interest in the program.

➤ **Core Review—Larry White**

The interim report is being sent to the ministry today. There is a key report about the accomplishments and key opportunities for advancement and direction. Also a institution accountability report. A few brainstorming sessions have been held. These reports will give the ministry the sense of the direction the college is intending to go. It has been suggested to the ministry ways to make our planning easier. It is very difficult to plan multi-year funding so we can more effectively work with First Nations communities and preparing communities for LNG. The draft will be circulated to EDCO as an FYI and will be discussed at the next meeting.
