EC.17-45.1	Practical Nursing
	The recommended change requested on the September 8 2017 EdCo meeting were made. All of the requested documents have been provided. The Health Cluster did meet, no signatures on the forms provided but cluster chair, program Dean, Carrie Nolan and the Registrar have approved the documents. After today, this will go on to

Clarification of PNUR 103 being listed as an admission requirement. This course is not currently offered and only students who took the previous PN program would have this course. If this is going to be a stand-alone course, they would need to apply to a program in order to take it. Students can also take BIOL 131/132 for this A & P requirement.

# Housekeeping items:

Second to last bullet in admission requirements should read "NWCC PNUR 103 or equivalent or (NWCC BIOL 131 or 132 or equivalent).

The 5 year requirement should be removed from the BIOL 12 requirement.

This line "with no band less than 6.0 and overall 6.5 in the IELTS admission requirement" can be removed as we have an equivalency table on the website.

There needs to be an "F" added to the additional admission requirements title.

# EC.17.45.2 Early Childhood Care and Education - Darlene Westerman

The requested changes have been made. The added pieces include: "students can opt out of the diploma program" on Page 3. The course numbers have been renumbered. There was a certificate option added – students can now complete courses required by the province and apply for an NWCC certificate. Admission requirements from the diploma also had an addition which was the completion of the ECCE certificate.

# Housekeeping items:

Add "Care" to the final line of the program requirements for the diploma.

Add to the admission requirements for previous ECE certificate graduates to be able to enter the diploma program.

Remove First Nations English 12 from the admission requirements.

Add a note that students entering the diploma program can enter the certificate.

### EC.1745.3 CSLI Pathway - Stephen Salem

The Canadian second language institute CSLI offers second language training for students wishing to enter post-secondary education. CSLI Level 9 meets grade 10 or 11 requirements. It is roughly IELTS 5.5-6.5 and CSLI Pathway program Level 10+ to meet Grade 12 requirements. Level 10+ equates to overall 6.5 with no band lover than 6.0.

# Carried

Motion to to add CSLI level 9 as a means to meet the Grade 10 and 11 requirements. It is roughly IELTS  $5.5^{\sim}$  6.5 and CSLI Pathway Program (level 10+) to meet Grade 12 requirements.

EC.17-45.4	Pearson English Test
	The Pearson's exam is accepted by UBC, BCIT, and Royal Roads. To continue expanding access to international students, this exam should be added to NWCC entrance requirements. These scores align with the IELTS score, and the minimum band can be used for each academic level, no band lower than 42 overall 50.

	In ACPAC terms of reference, Internal transfer credit needs to be reviewed by ACPAC and approved by Education Council. Internal transfer credit should be reviewed on continuing basis. Added to line 5.02 in the policy that internal transfer credit must be approved by Education Council.
