Granting of Credentials Policy and Procedure – Education Policy Committee (10 minutes)  ➤ Notice of Motion: To accept the Granting of Credentials Policy and Procedures as presented.	EC.25.56.02
Discussion:	
<ul> <li>Provided an overview of the proposed revisions to the policy and procedure, highlighting that the update originated from discussions around micro-credentials.</li> <li>The policy introduces both credit and non-credit micro-credentials, which maintains a broad language as the provincial framework is still underway.</li> <li>Revisions were made to clarify responsibilities, who has the authority. For example, posthumous credentials.</li> <li>Updates were completed for readability and clarity.</li> <li>Question about the possibility of converting non-credit micro-credentials to credit and how this might affect transferability. The work is underway across BC, led by BCCAT (BC Council on Admissions and Transfer), to establish frameworks for credit micro-credentials and potential stackability.</li> <li>Question about transferability. It was noted that this is a future goal once creditbearing micro-credentials are formally established.</li> <li>It was noted that CMTN is at the introduction stage as of the moment.</li> <li>Question about Office Essentials Micro-credential appearing on the EducationalPlannerBC as transferable to Business Administration. Colin and Emily to follow up with the EducationPlannerBC to ensure accuracy.</li> <li>Final Motion at the next EdCo meeting.</li> </ul>

<ul> <li>Land Acknowledgement and Efforts of Reconciliation</li> <li>Coast Mountain College collaborates with six First Nations in northwest British Columbia, the Haida, Ts'msyen, Nisga'a, Haisla, Gitxsan, and Witsuwit'en as well as the Tahltan and acknowledges the traditional territories where its campuses stand.</li> <li>Discussion:         <ul> <li>Marja is focusing on relationship, responsibility, and respectfulness. Especially this period of time, where there are institutional changes. How kindness and compassion are important, looking out for themselves, friends, colleagues, and peers.</li> <li>Titi expressed appreciation for the focus on kindness and compassion during challenging transition. Recognizing the tension of administrative duties. It was noted that it is heavy on their mind and hoping it will come out for the best.</li> <li>Dawn recommended the book Shared Histories: Witsuwit'en - Settler Relationships in Smithers, British Columbia, 1913-1973 by Tyler McCreary. It emphasizes the systemic injustices faced by the Indigenous communities and the importance of ongoing self-education and understanding of local Indigenous histories. It is hard to read and the least we can do is to read and inform ourselves.</li> <li>Emily reflected on her family's Mennonite history and the importance of acknowledging settler benefit and Indigenous generosity. Recognizing how to honor and continue those relationships ethically.</li> <li>Melanie shared a classroom experience (Fundamental English class) involving the repatriation of Indigenous artifacts, noting the powerful impact on students who were mostly First Nations. Highlighted the value of experiential learning and storytelling in bringing Indigenous histories and cultures to life for students.</li> <li>Priscilla discussed Indigenous governance, the inclusion of all members in traditional systems, and the resilience of First Nations community despite of the generational trauma and</li></ul></li></ul>	EC.25.57.01

reconciliation conversations with celebrations of success within Indigenous

<ul> <li>Encouraged members to engage with the Indigenous hub and online resources, offering opportunities for collaboration and further learning.</li> </ul>

<ul> <li>Presented as an information item. Not a standing committee of EdCo but Council has a limited connection in terms of settling standards for academic excellence.</li> </ul>	
<ul> <li>Yvonne Koerner, Foundation Lead, has successfully increased funding availability for students.</li> </ul>	
<ul> <li>New software has been implemented to allow students to submit one application that automatically assesses eligibility for all awards. It reduces missed opportunities and improves efficiency in awarding funds.</li> </ul>	
The committee membership scaled down from 25 members to a smaller group to limit unnecessary access to sensitive student information.	
Faculty are invited to participate only for awards relevant to their program area.	
<ul> <li>Ongoing manual oversight ensures all students are considered for applicable awards.</li> </ul>	
<ul> <li>Question about specific eligibility criteria (e.g. family or employment connections). It was noted that it is accounted or built in as a question on the awards application in the software.</li> </ul>	
<ul> <li>Acknowledged Allison Conway who spent months designing the system to handle complex award criteria, including filtering and eligibility checks.</li> </ul>	
<ul> <li>Some membership updates are required due to changes in job titles, and this will be addressed at the next Awards Steering committee meeting.</li> </ul>	
The changes aim to balance donor intent, student access, and privacy.
