### Dear CMTN Student:

Our on-campus Housing is convenient, offers excellent value, and provides an alcohol and smoke-free environment that is conducive to learning.

Once we receive your application, we will either offer you a space in Housing or the option to be placed on a wait-list for space as soon it becomes available. Upon acceptance to Housing, you are required to pay a non-refundable application fee and damage deposit (refundable at check-out). Once this payment has been completed, your room assignment will be confirmed by email.

#### Payments

The total amount payable for your stay is \$2,750.00 for your first semester (including application fee and damage deposit). Before you move into the dorm, your first month's rent of \$600.00 must be paid no later than the last day of the previous month (for example, September rent is due by the last day of August).

For the following payment options for the monthly rent, we accept Visa, MasterCard or American Express. Please note that Visa debit is not accepted.

    - Select "Next," then select "Set Up Payments."

Your application fee, damage deposit, and first month's rent must be paid BEFORE you can check-in. Check-in hours are Monday to Friday, from 8:30 a.m. to 3:30 p.m.

Before you can move into the dorm, you MUST complete an intake process with the Student Housing Office during regular office hours (Monday to Friday from 8:30 a.m. to 3:30 p.m.).

As part of this process, you will have your picture taken and a student ID will be created for you. Your student ID is also your key for accessing the dorms.

Cleaning must be completed at the time of cooking.
